We are writing to remind you that, in accordance with Section 2.1.1.4 of the Fund’s prospectus, the Board of Directors has established minimum initial and ongoing holding requirements for each share class, as outlined in *Appendix VI – Minimum Investment and Holding Amounts*.

As part of our regular oversight and in line with regulatory and fund documentation standards, the Board of Directors reviews investor holdings to ensure continued compliance with these thresholds.
